Appendix A: Further Device Details

ADM Modular Brace System

The ADM Modular Brace System Comprises numerous specific devices, each with a Unique Device Identifier. The devices fall into a range of Categories as listed below that are further defined by the C-Pro Direct spreadsheet referenced 093_TECH v017 which is available at www.c-prodirect.com

1. ADM Sandals / AFOs: Night use Ankle Foot Orthosis (AFO) for prevention of clubfoot relapse when used ADM Modular Brace System configurations (093_TECH Category 30)
2. ADM: Abduction Dorsiflexion Mechanism (093_TECH Category 31)
3. ADM (X-L size): Abduction Dorsiflexion Mechanisms in the XL size for use on feet sized between 220mm and 270mm in length (093_TECH Category 33)
4. ADM External Rotation Bars: External Rotation Bars for use as a foot abduction brace (093_TECH Category 32)
5. ADM Bar Clips: Used with ADM External Rotation Bars to form a Clubfoot External Rotation Brace (aka Denis Browne Brace) (093_TECH Category 35)
6. Spring Assisted Articulating Bar Clips: A variant of ADM Bar Clips that can be used with ADM External Rotation Braces to creates an Articulating External Rotation Bar (aka Dobbs Brace) (093_TECH Category 36)
7. D-Bar Europe: Articulating External Rotation Bar (aka Dobbs Braces) for use with Mitchell, Markell and IOWA clubfoot brace systems (093_TECH Category 28)
8. ADM Footwear: Adapted footwear for use as braces as part of the ADM Modular Brace System (093_TECH Category 16)
9. ADM Sole Kts: Kits to enable Orthopaedic workshops / persons skilled in the craft to adapt or make footwear that can be used as part of the ADM Modular Brace System (093_TECH Category 36)
10. Black Robin Socks: Accessories to the ADM Modular Brace System AFO products recommended to protect skin and promote good foot health (093_TECH Category 5)
11. Fitting Stock: Collections of ADMs Bars and Clips in an easy to use dispensing box and AFO liners for determination of patient foot size (093_TECH Category 17)
12. ADM Strap Pads: Accessories to the ADM Sandals / AFO. Strap Pads are supplied with all ADM AFOs, but are also available separately as spares (093_TECH Category 19)
